## **UPDATE: Curfew Order – Unincorporated San Diego County**

The Sheriff's Department and all law enforcement agencies in San Diego County stand united in supporting the public's right to express their anger and frustration over the death of Mr. George Floyd through peaceful protests.

However, when those demonstrations turn violent and threaten life and property, law enforcement must act to restore safety in our communities.

Due to the violence and property damage we have seen over the past few nights, a curfew order will go into effect for some unincorporated areas of San Diego County beginning **tonight at 8:00 p.m. and lasting through 5:30 a.m. on Tuesday, June 2<sup>nd</sup>.**

Areas affected by the curfew include:

- **Areas around Spring Valley** - Unincorporated areas east of the boundaries of the Cities of La Mesa and San Diego to State Highway 54; north and west of State Highway 54 from the boundary of the City of San Diego to the boundary of the City of El Cajon; and south of the boundary of the City of El Cajon to the west of State Highway 54.
- **Areas from Lakeside north to Poway** – Unincorporated areas west of State Highway 67 from the boundary of the City of Poway to Mapleview Street; areas south and west of Mapleview Street and Lake Jennings Park Road to Interstate 8; areas north of Interstate 8 from Lake Jennings Park Road to the boundary of the City of El Cajon.

All residents in these areas are urged to stay home, indoors and off the streets. Violation of the curfew order is a misdemeanor and is subject to a fine of up to \$1,000 or up to six months in jail or both.

All local, state and federal law enforcement agencies will work together to enforce these orders and ensure the public's safety.

**ORDER OF CURFEW AND CURFEW REGULATIONS**  
(Pursuant to San Diego County Code of Regulatory Ordinances section  
31.301(a))

It shall be unlawful for any person to travel or be upon a public street, sidewalk, or public place within the area described below during the dates and hours designated below, unless exempt for the reasons set forth below. For purposes of this Curfew Order and Curfew Regulations, "travel" includes, without limitation, travel on foot, bicycle, skateboard, scooter, motorcycle, automobile, or public transit.

This Curfew is in effect from June 1, 2020 at 8 p.m. until June 2, 2020 at 5:30 a.m.

The areas subject to the curfew are as follows:


Areas around Spring Valley – Unincorporated areas east of the boundaries of the Cities of La Mesa and San Diego to State Highway 54; north and west of State Highway 54 from the boundary of the City of San Diego to the boundary of the City of El Cajon; and, south of the boundary of the City of El Cajon to the west of State Highway 54.

**Areas from Lakeside north to Poway** - Unincorporated areas west of State Highway 67 from the boundary of the City of Poway to Mapleview Street; areas south and west of Mapleview Street and Lake Jennings Park Road to Interstate 8; areas north of Interstate 8 from Lake Jennings Park Road to the boundary of the City of El Cajon.

Exemptions: All law enforcement, fire, medical personnel, and members of the news media are exempt from this Curfew. Individuals traveling directly to and from work, seeking emergency care, fleeing dangerous circumstances, or experiencing homelessness are also exempt.

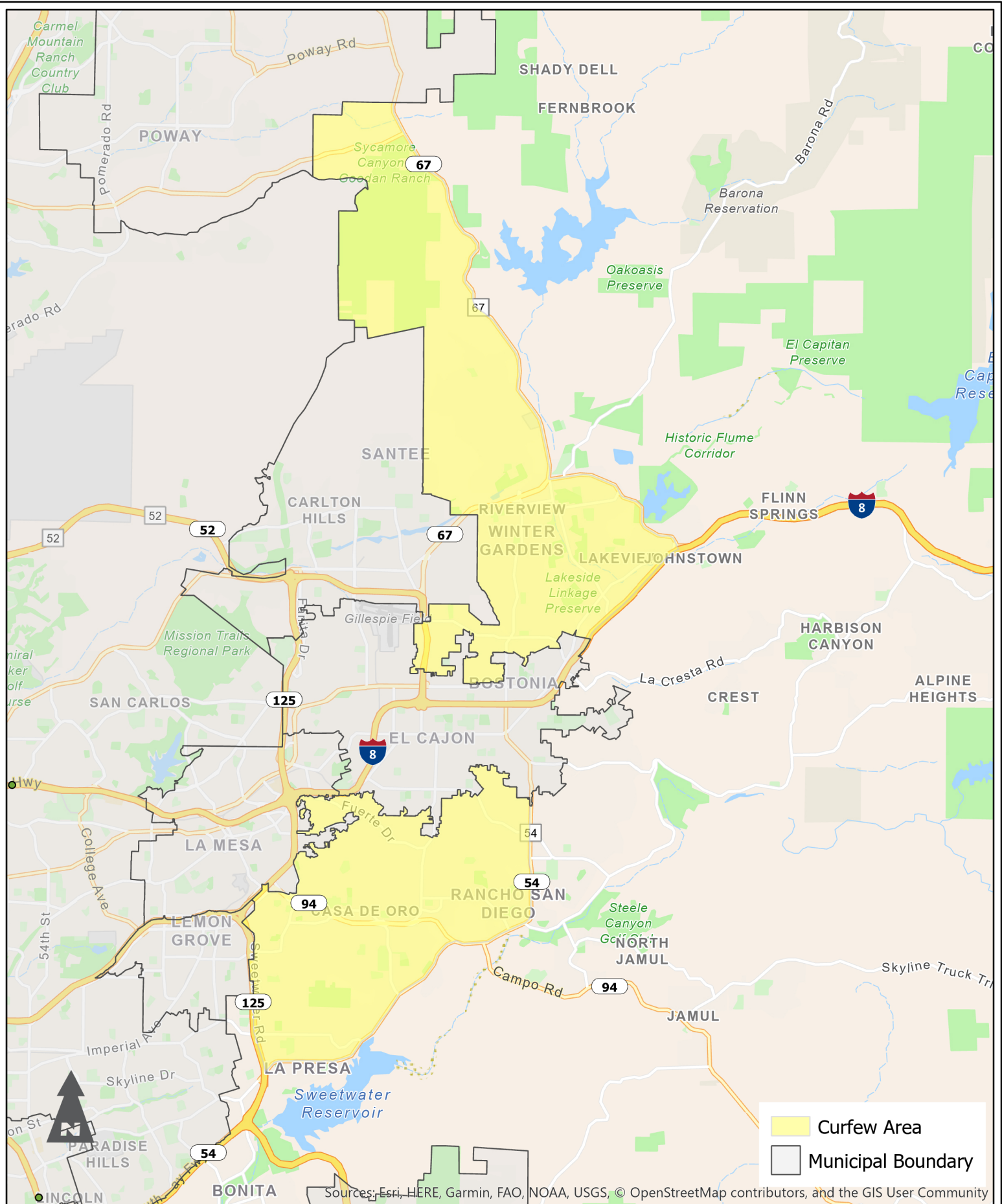
