## Sex Offender Community Notification

On November 12<sup>th</sup>, Sheriff's Deputies along with the SAFE Task Force went door-to-door in Jacumba Hot Springs and Boulevard to inform the community about a Sexually Violent Predator (SVP) who will be living in their neighborhood. Joseph Bocklett served time in prison for molesting children between 1976 and 2000.

On or before 12/01/20 the San Diego Superior Court has granted Bocklett's conditional release at 45612 Old Highway 80 in Jacumba Hot Springs under the supervision of Liberty Health Care.

**The San Diego County Sheriff's Department, District Attorney's Office and SAFE Task Force are not responsible for the selection of this location. The selection process was the responsibility of the Department of State Hospitals and the San Diego Superior Court.**

Bocklett is not wanted by the Sheriff's Department at this time. California Penal Code Section 290, also known as "Megan's Law," permits law enforcement agencies to warn the community about sex offenders who frequent the area. The purpose of this notice is to allow members of the public to protect themselves and their children from sex offenders.

This notification is not intended to induce fear; rather it is our belief that an informed community is a safer community. Use of this information to threaten, intimidate, or harass the subject or any other person will not be tolerated and may result in prosecution.
