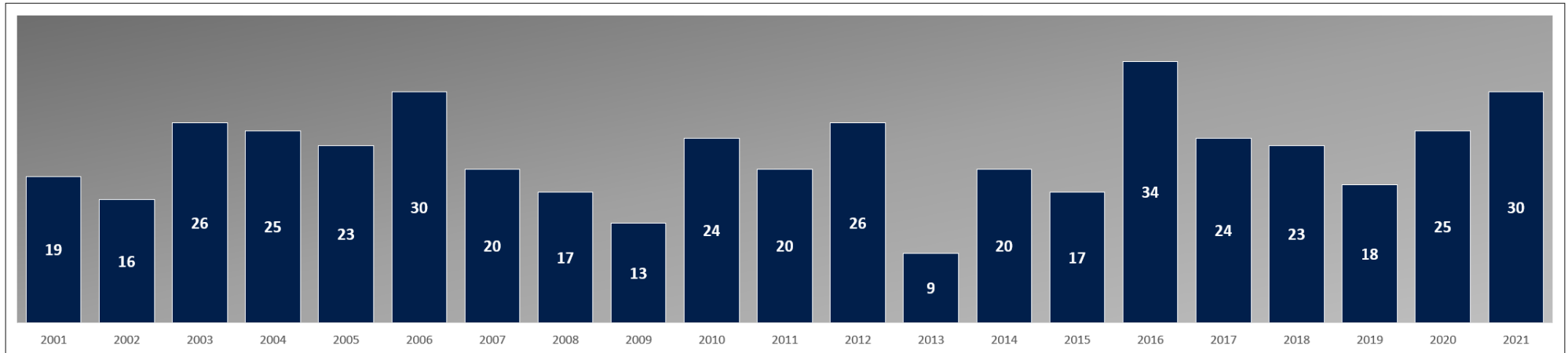

Homicides by Year



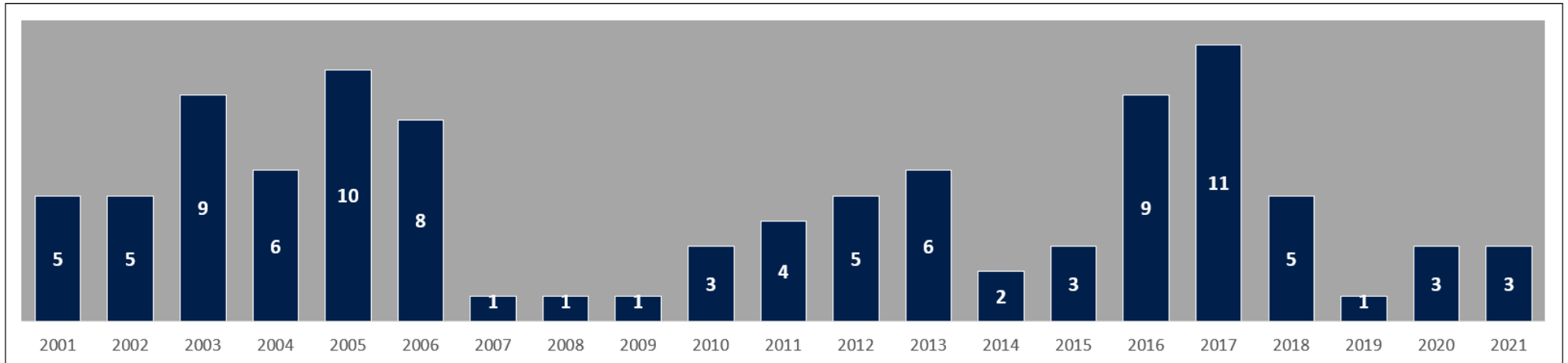

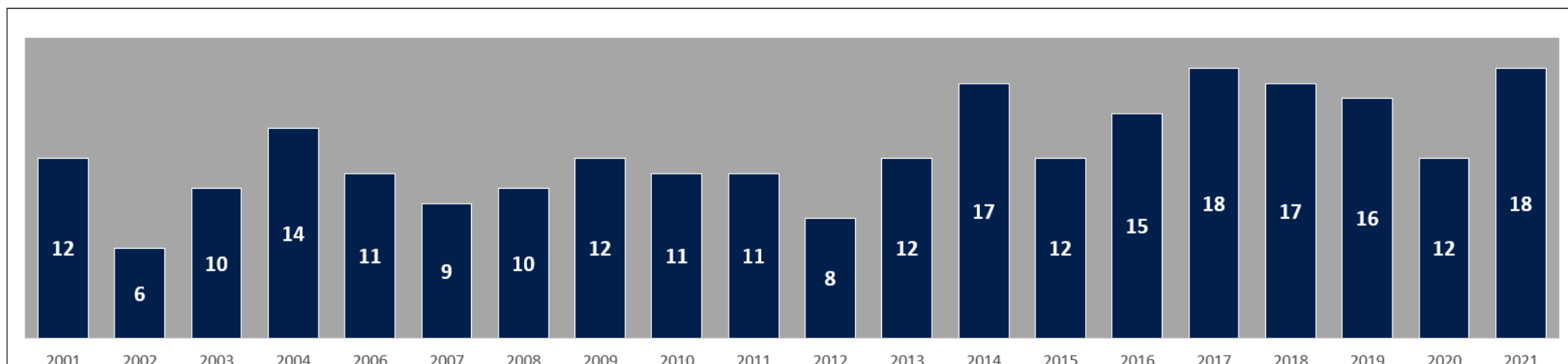
