# **Restraining Orders & Other Advisals**

A restraining order is a court order issued to prevent the recurrence of acts of abuse or harassment. If a Temporary Restraining Order (TRO), Restraining Order (RO) or Criminal Protective Order (CPO) has been issued, do not have any direct or indirect contact with the protected party even if you do not initiate the contact. If you own or possess a firearm and you are the restrained party of any restraining order, you must surrender the firearm to any local police station. A Drug Court is a special court that hears selected felony and misdemeanor cases involving non-violent, drug-using offenders.
